

### Annex B - Breakdown of Respective Cost Items by Flat Type

The Government will pay up to 95% of the cost of the EASE improvement items for Singapore citizen households, depending on the flat type. Flat owners can choose any combination of the improvements that best meets their needs and pay only for what they have selected.

The table below shows the cost breakdown payable by flat owners (figures in the table below are inclusive of GST). Flat owners pay between 5 to 12.5% of the costs, depending on their flat type.
